As the Director of Facility and Capital Management at MITT, you will play a pivotal role in overseeing the strategic planning, development, and maintenance of our physical infrastructure and capital assets. This leadership position requires a blend of operational expertise, financial acumen, and visionary thinking to ensure our facilities support the institution's mission of excellence in education.

Responsibilities include but are not limited to:

- Strategic Planning: Develop and implement long-term facility plans aligned with institutional goals and growth projections.
- Capital Budgeting: Manage the capital budgeting process, including forecasting, allocation of resources, and prioritization of projects.
- Project Management: Oversee the planning, execution, and completion of capital projects, ensuring they are on time, within budget, and meet quality standards.
- Real Property: Manage real property transactions (i.e. property purchases, zoning variances, etc.) and lease management (i.e. new leases, extensions, renewals, negotiation and administration)
- Facilities Maintenance: Implement proactive maintenance programs to ensure the safety, functionality, and aesthetics of all facilities.
- Compliance and Safety: Ensure compliance with building codes, regulations, and environmental standards. Develop and enforce safety protocols to protect the campus community.
- Risk Management: Lead emergency management, security, safety and compliance planning.
- Sustainability Initiatives: Lead sustainability efforts related to energy efficiency, waste reduction, and environmental stewardship across campus facilities.
- Collaboration and Communication: Foster collaboration with academic and administrative departments to understand their facility needs and provide responsive solutions. Communicate effectively with senior leadership, presenting plans, progress reports, and budget updates
- Vendor and Contractor Management: Manage relationships with external vendors, contractors, and consultants to support construction, renovation, and maintenance activities.
- Bachelor's degree in Engineering, Architecture, Facilities Management, Business Administration, or a related field.
